

### Diamond Debenture

### **TERMS AND CONDITIONS - 2016 2017 2018**

- "U.J.B10K.R. Ltd." shall mean Union Jack B10k Run Ltd.
- rights during each year of the term subject to the terms of this agreement: 6 guaranteed entries, ("Guaranteed Entries").
- "Terms" shall mean three years from the date of application
- "Event" shall mean the 10 kilometre road race through the streets of London organised by the U.J.B10K.R. Ltd. and known as The British 10K London 10. U.J.B10K.R. Ltd. shall have the absolute right to terminate any Diamond
- "Debenture Holder" shall mean the registered charity who applied for the Debenture(s)
- 2. Applications for a Diamond Debenture together with a payment of the Price shall be made on or before 31st December each year.
- 3. The allocation of Diamond Debentures shall be on a first come first served basis. However U.J.B10K.R. Ltd. reserves the right to refuse to allocate Diamond Debentures to applicants without giving any reason. Applications will only be accepted on an official form and only quality photocopies will be accepted. Any application accompanied by a cheque which is not met on
- first presentation shall be rejected and an additional fee of £30.00 charged. 4. Successful applicants will receive the Diamond Debenture certificate which is issued strictly in accordance with the terms and conditions set out herein, and the terms and conditions of the Event.
- 5. Debenture holders shall be entitled to the rights throughout the Terms subject to the restrictions herein and such other regulations as U.J.B10K.R. Ltd. shall make in writing from time to time including the terms and conditions applicable to participants in the Event.
- 6. The rights and their exercise shall be subject to the following
- i. Guaranteed Entries shall not be sold or offered for sale, nor may they be used in any way in connection with, or as part of any competition, lottery or promotion save one that is open only to employees of the Debenture Holder and the Debenture Holder is a registered Charity. The Debenture Holder may publicise the availability of Guaranteed Entries to the public in the media and only then in such form as U.J.B10K.R. Ltd. shall authorise in writing if necessary.
- ii. Guaranteed charity entries shall only be used by a person who is 15 years or older on the date of the event.
- iii. U.J.B10K.R. Ltd. reserves the right in its absolute discretion to refuse to allow entry to the Event to any person.
- iv. The Debenture Holder shall be responsible for ensuring the fitness and suitability for the Event of persons to whom the Guaranteed Entries are given. Charity team runners must be able to complete the course within
- v. Guaranteed Entries shall only be valid if the appropriate completed form is returned to the Event before the closing date for each event.

  - under any circumstances whatsoever through to 2018. Debenture holding charities may increase the number of debentures each year if debentures are available, but not decrease from the
  - number purchased in the first year. Charities will be invoiced a maximum of twice between the 1st September and 1st December each year and again in January the following year. If it is necessary to send further reminders they will be
  - charged at £50.00 each. 19. Charities must advise their runners not to bring excessive valuables or cash to the baggage bays on race day - the organisers cannot accept responsibility for any loss or damage
  - 20. If the charity winds up or otherwise ceases operation during the period of the contract any outstanding years left on the contract are still payable. The charity must notify Union Jack B10k Run Ltd. in advance of any action to cease operation.
  - 21. If the charity changes it's name during the period of the contract any outstanding years left on the contract are still payable by the new entity.
